On the Shoulders of Giants

Every successful lawyer stands on the shoulders of giants who went before. I certainly recognize that I would not be the lawyer I am today, without great people in my life, who encouraged me to "be better," "care for others," "love learning," and to have faith.

The first of these was my dad.

He died when I was only 13, but he was firm in his ethic that his kids would always tell the truth, would always show respect to others, and would never settle for "good enough". In his lifetime he volunteered to serve on a submarine in World War II. He went to school on the GI bill and graduated top of his class from Law School. He established himself as one of the best criminal defense and civil trial lawyers in the State. He became a licensed private pilot, flying both single engine planes and powerless "gliders" as well. He did all of this and was a pretty good dad, to boot.

I took from him an uncompromising ethic to always do the best for my kids and my clients. Always improve myself. If I should come up short, admit it and make it right. I do not strive to be perfect, but I won't accept less than the best I can do.

My mother, too, was a great inspiration.

When my dad died, he left behind nine kids. Of those nine, still at home were three boys (including me) and my youngest sister. My mother showed incredible strength and faith after my dad passed. She was tireless in making sure we made it off to school each day with a hot breakfast, a lunch packed, and a hot dinner served at the family table every night. She got us to church every Sunday, and she made sure we received a solid education from a local Catholic high school.

We were not perfect kids. At times, I know, she would have loved the stern hand of my dad to "shape up" one or another of us. But she always showed us love, and patience, and kindness. She modeled "faith," like no other in my life.

From her, I learned empathy, compassion, and faith in the better nature of people. She lived to be 75 years old, and for all that time, she always put the interests of her family first. She never thought twice about the cost to her. Today, I try to carry that forward.

In high school and college, I had three teachers who were very influential. They were

CASE RESULT:

Trucking Company Pays Teen Worker for Crushed Pelvis Injury



One evening, a 19-year-old male college student was injured at his part-time job. He contacted the Law Office of Matthew A. Lathrop because he thought the workers' compensation insurer was treating him unfairly. After he came in, Matthew learned that the teenager not only had a workers' compensation claim but also a significant claim against the trucking company.

The night of the accident, the teenager went outside to help unload a semi-truck delivery. There was an awkward and narrow path for the truck to get to the loading dock. The teen was standing on the loading dock when he was hit by the truck that was going in reverse.

He was pinned between the truck's back bumper and the railing of the loading platform for several minutes. As the truck pinned him, the teen heard his bones breaking. The pain of a crushed pelvis and other injuries was overwhelming. He screamed, then a co-worker heard him and notified the trucker.

Why the Truck Company Settled

The accident happened around 9 p.m. The trucker had started his day around 6 a.m. and traveled to multiple states by the time he arrived at our client's workplace. His logs were in compliance with federal regulations, but it was a long day and he was tired.

First, Matt got to work straightening out the client's workers' compensation benefits. Quickly, his employer

stepped up to pay his medical bills.

Turning to the trucking case, Matthew hired an expert on trucking rules to determine what happened and whether the trucking company could be at fault for the teen's injuries. According to the expert, a trucker has a responsibility to know if people are around the truck before he backs into a loading dock. The only way a trucker can know if people are around is to get out of the truck and walk around it to make sure the area is clear. If anyone is in the area, it is the trucker's responsibility to tell them where to stand so that they are safe.

During his deposition, the trucker admitted that it is his job to know if people are around. He knew our client was nearby, but he did not get out and check on his specific location.

After the deposition, the trucking company agreed to settle our client's case for a confidential amount of money.

The Accident Cost Our Client a **Year of His Life**

At the time of the accident, our client was working part-time while going

to college as a full-time computer engineering student.

He was hospitalized for an extended amount of time after the crash. He had surgery, but he has suffered permanent nerve problems that still affect him during high impact exercise or running.

After the accident, he couldn't work, he couldn't go to school, and he couldn't live on his own. He had to move back in with his parents. He ended up graduating college a year later than he otherwise would have if not for the truck accident.

The truck accident settlement not only compensated him for his damages, but it also made him feel heard.
